- 6. The minutes from the previous meeting were read and accepted Proposed Derek Salvage and Seconded Mike Barnes
- 7. Feature Speaker Rick Burris (Open Spirit) made a presentation of the next generation of Open Spirit, with emphasis on the management of geodetic functions. The goal is to provide total interoperability between databases and applications. There are many applications and databases and these cannot communicate across platforms and operating systems. There is a huge variety of formats and heterogeneous datasets and no shared displays outside of each application.

Rick was keen to point out that Open Spirit is not:

- 1. An end user G&G application
- 2. A database
- 3. A GIS system

Open Spirit is an integration framework that sits between applications and Open Spirit interface. It tries to meet the business objectives through a subsurface and drilling data model. For example combining Seismic data from a SEGY DB, horizons from Geoframe and Wells from Openworks.

Major problems surround the combination of languages and operating systems and the management of metadata.

Rick went on to describe the way in which Open Spirit intends to manage the transfer of geodetic and cartographic metadata during the sharing process.

There was a great deal of discussion after the end of the formal presentation. Some concern was expressed that even the most recent applications are not yet able to manage the storage and implementation of metadata within their own structure. A second point was a lack of provision of audit trails and warnings when limits of computational models were reached.
