Membership Renewal Process

Membership Classifications

- Active = "Approved Full Member who is current with dues payment"
- Associate Member = "Associate Member who is current with their dues payment"
- Pending New is "Active or Associate Member under application approval, or payment of initial year dues, or both"
- Lapsed Member is "Active or Associate Member who is delinquent on dues payment and has member privileges suspended until current"

Membership Dues Payment Policies

- Dues cover calendar year
 - Payment requested by January 30 each year
- Must be current with dues to:
 - Vote
 - appear in the member directory
 - have full web access rights
 - and other member privileges
- Members become Lapsed in their Dues on July 1
 - Lose member privileges until current with dues
- Lapsed members may not vote until all unpaid dues are paid (starting with 2009)

Payments and Reminders

- Payments received are applied to earliest unpaid period
 - catch up on unpaid years starting with 2009
- Courtesy Reminders to be sent out by email
 - January 1st (dues are requested)
 - January 31st (dues are now late)
 - 1 month prior to Spring meeting
 - July 31st (now Lapsed)
 - 1 month before Fall meeting (elections in the fall)

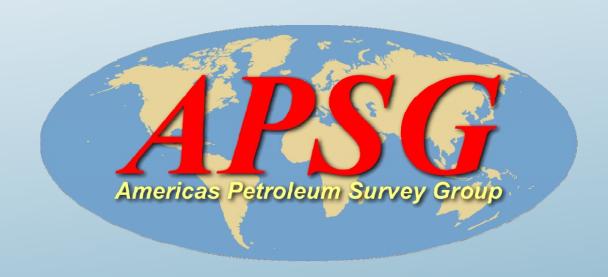
Dues Payment Methods
